

**Application Guidelines for International Course (Foreigners and Returnee Children)**  
**Transfer Applicants for the 2026 Academic Year (2<sup>nd</sup>-6<sup>th</sup> Grade)**

Elementary School Attached to the Faculty of Education, Kumamoto University (hereinafter referred to as “the school”) will open an international course for all grades in April 2026, and will be accepting applications for foreign and returnee children.

The school is about 150 years old and has a long history of the child-centered class implementation and the distinctive school education and practices. The school aims to advance educational reform to develop students' academic abilities, language skills, and global mindset by providing an English-immersive learning environment in our International Course. In this course, Japanese and non-Japanese students will have many classes in an environment where foreign languages (English and Japanese) are used in accordance with the curriculum based on the National Curriculum Standards in Japan.

Parent(s)/guardian(s) of applicants applying for admission to the school are requested to fully understand the educational policies and characteristics of the school and its International Course before applying for admission.

Parent(s) or guardian(s) of applicants who wish to enroll in the International Course from the domestic school where the applicant is currently enrolled or from a foreign educational institution must fully understand the educational policies and characteristics of the school and the International Course.

※ As an affiliated school of a national university, our school missions are conducting pre-service teaching training for students of the Faculty of Education, Kumamoto University, and implementing educational research and practice by collaborating with the other affiliated schools: the kindergarten, the junior high school, the school for special needs education, and other research institutions. Therefore, unique activities based on our own educational plans will also be conducted.

## 1. Enrollment capacity

- Grade 2 A small number
- Grade 3 (approximately seven)
- Grade 4 (approximately seven)
- Grade 5 (approximately seven)
- Grade 6 (approximately seven)

※A few returnee children are included in the above number of students of each grade.

## 2. Qualifications

Applicants must meet all of the following conditions from (1) to (4).

(1) Applicants must be foreign children or returnee children and meet the following requirements:

- Foreign nationality or a returnee child (※)
- Interest in Japanese education in English (parent(s)/ guardian(s) also required)
- Ability to communicate in English

(2) Children of the appropriate school age for the 2026 academic year (Reiwa 8):

- 2nd Grade: Born between April 2, 2018 and April 1, 2019
- 3rd Grade: Born between April 2, 2017 and April 1, 2018
- 4th Grade: Born between April 2, 2016 and April 1, 2017
- 5th Grade: Born between April 2, 2015 and April 1, 2016
- 6th Grade: Born between April 2, 2014 and April 1, 2015

(3) Applicants must live with their parent(s) or guardian(s) in Kumamoto Prefecture as their place of residence.

(Temporary residence in Kumamoto Prefecture is not accepted.)

- For applicants who live outside of the prefecture, etc., please submit a certificate of expected relocation by the parent(s)/ guardian(s) (Letter of Confirmation for Change of Address Form) at the time of application.

(4) In principle, applicants must be able to walk or take public transportation to school from their place of residence within 50 minutes.

※For children who have returned to Japan, the applicant must meet all of the following conditions.

- ① Those who have Japanese nationality and have lived abroad for one or more years in a row.
- ② Those who return to Japan between April 1, 2025 and March 31, 2026.

### 3. School orientation for the parent(s)/guardian(s) of applicants

② Please be punctual.

③ Up to two parent(s)/guardian(s) are required for the event. Please refrain from bringing the applicant or other children to the orientation.

④ Please prepare indoor shoes.

⑤ Lesson observation will be held before the information session.

As it is an important opportunity to deeply understand our educational principles and practices, please be sure to attend the school's information session. In principle, application documents for admission will be distributed during the orientation. However, in case if you are not able to attend on the orientation, please contact us by phone in advance between 9:00 AM and 4:00 PM (excluding 12:00 PM to 1:00 PM) from Monday, October 27th to Friday, October 31st only). If you are currently living outside of Japan, and cannot come in person to, arrangements can be made to view the orientation online. Please contact us by phone or e-mail for more details regarding this.

### 4. Application period and procedures

(1) Submission of the application documents:

Between 9:00 AM and 4:00 PM (excluding from 12:00 PM to 1:00 PM) from Monday, November 10, 2025 to Friday, November 14, 2025.

(2) Required documents:

- ① Application for Admission
- ② Route Assignment Notification
- ③ Certificate of Residence (Juminhyo, original document issued within three months)
- ④ Application Fee: 3,300 Japanese yen (non-refundable, cash only.)
- ⑤ Additional Requirements:
  - (i) For foreign children:
    - A copy of the passport AND of both sides (front and back) of the residence card issued

by the Japanese government (Minister of Justice), or a copy of another official document showing foreign nationality.

- ※ The documents must be valid at the time of application and include: the applicant's name, photo, date of birth, nationality, ID number, etc. (For residence cards, the period of stay must also be included.)
- ※ The original passport, residence card, and other official documents must be presented in person at the application counter to verify the information. If you are still waiting for a new or renewed residence card, notify the school at the time of application. Then, bring both a copy of the new card and the original card to the school on the examination day.

(ii) For returnee children:

- A copy of the passport or other official documents showing the length of stay abroad.
  - ※ It must include the period of overseas residence (dates of departure and arrival) of the applicant taking the examination.
  - ※ The passport should clearly show the entry and exit dates of the applicant taking the examination. It must also include the applicant's name, photo, date of birth, nationality, and passport number. The passport must be valid at the time of re-entry into Japan or the time of the submission.
  - ※ If the passport does not show the entry/exit stamps (e.g. due to using an automated facial recognition gate), you must request a record disclosure from the Immigration Services Agency of Japan. Since this process takes time, please begin preparations early.
- A certificate of enrollment issues by an overseas educational institution.
  - ※ When submitting the Application for Admission, present the original passport at the counter to verify the contents.
  - ※ If it is difficult to submit a certificate of enrollment issues by an overseas educational institution, please contact us in advance.

(3) Submission documents:

Please submit the application documents by hand to the office of the school before the deadline.

- ※ Reception slip (uketsukehyo) and receipt will be issued after the submission.
- ※ If you are living overseas and cannot submit the application in person, we can accept applications online. Please contact for details of this.

**5. Entrance examination for transfer applicants**

- (1) Date: Saturday, December 20, 2025
- (2) Venue: the school
- (3) Test Details: Math and English will be tested along with an interview. Questions and answers for the tests and interview will be in English. Along with applicants' testing, the parent(s)/guardian(s) are also interviewed to confirm the intent of a applicant's enrollment at our school (Interviews are either in English or Japanese).
- (4) Method: Successful applicants will be decided by their examination results.

※ The process will be finished after all interviews of applicants and parent(s)/guardian(s) are completed. Parent(s)/guardian(s) will be required to wait in a destined waiting room after each interview.

(6) Notice:

- ①Each applicant should be accompanied by either one parent or one guardian.
- ② Please bring:
- The reception slip (uketsukehyo) which was issued during the submission procedure of the application.
  - A pencil and eraser.
  - Indoor shoes (Applicants should bring shoes that do not have their name written on them.)
  - Water bottle (If necessary).
- ③ Please present your reception slip at the reception. You will be given an examinee number.
- ④The reception window will be closed at 8:45 AM. Please understand that an applicant who arrives late will not be permitted to take the examination.
